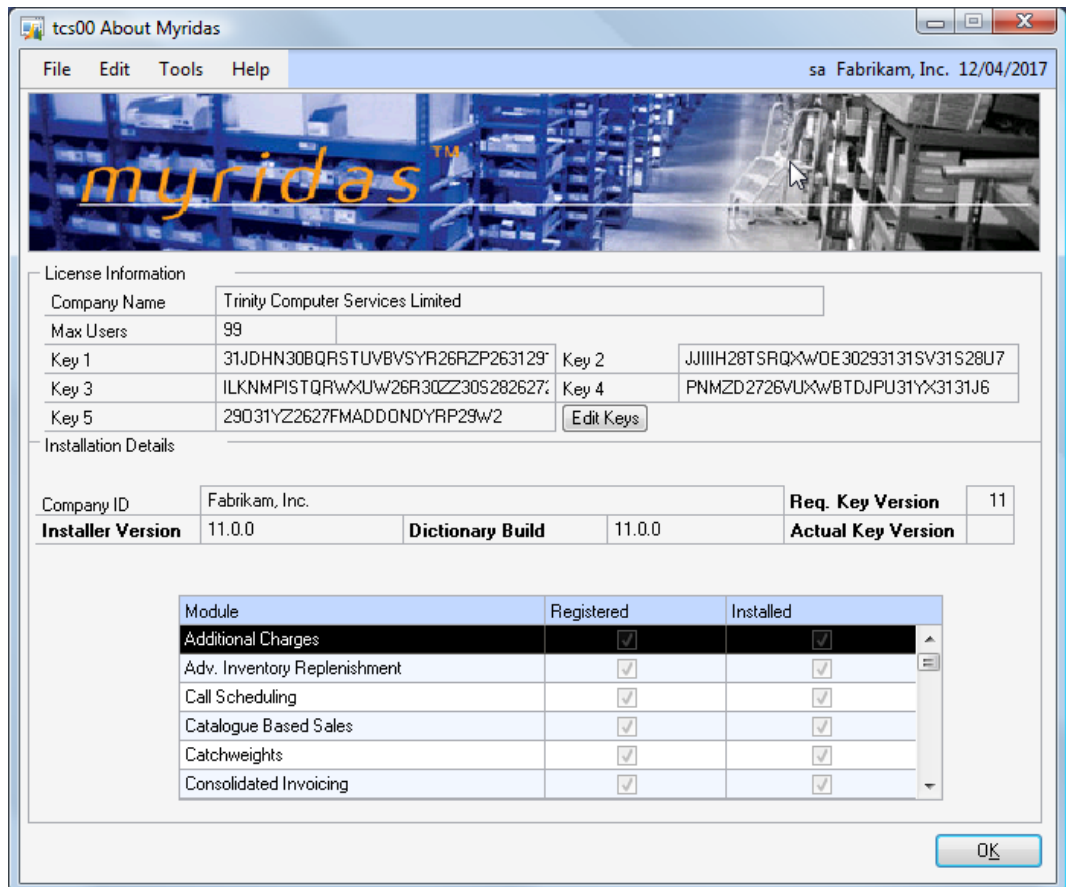

## Extended Pricing Enhancements

The Myridas Extended Pricing module provides additional functionality for Microsoft Dynamics™ GP Extended Pricing.

The key features of the Extended Pricing Enhancement module are:

- The facility to set up and use cost uplift prices
- Promotion information window displaying promotion details during sales transaction entry
- An alternative calculation for quantity free promotions
- The facility to include negative value adjustments on price sheets
- Visible discounts to view discount details for sales transactions
- Aggregate pricing based on multiple item purchases
- Site specific pricing
- Price list production
- Order value discounts based on total order value
- Aggregate promotions based on total quantity purchased from a list of items

The Myridas Extended Pricing Enhancements module is fully integrated with Microsoft Dynamics™ GP Extended Pricing. Please see [Appendix B](#) for full details of enhancements to specific Extended Pricing windows.

If you are using the Myridas Extended Pricing Integration module then cost uplift prices can be imported from or exported to an excel spreadsheet. See the Extended Pricing Integration User Guide for further details.

Note that if you have site specific pricing switched on then all price sheets in use must be assigned to a site price type.

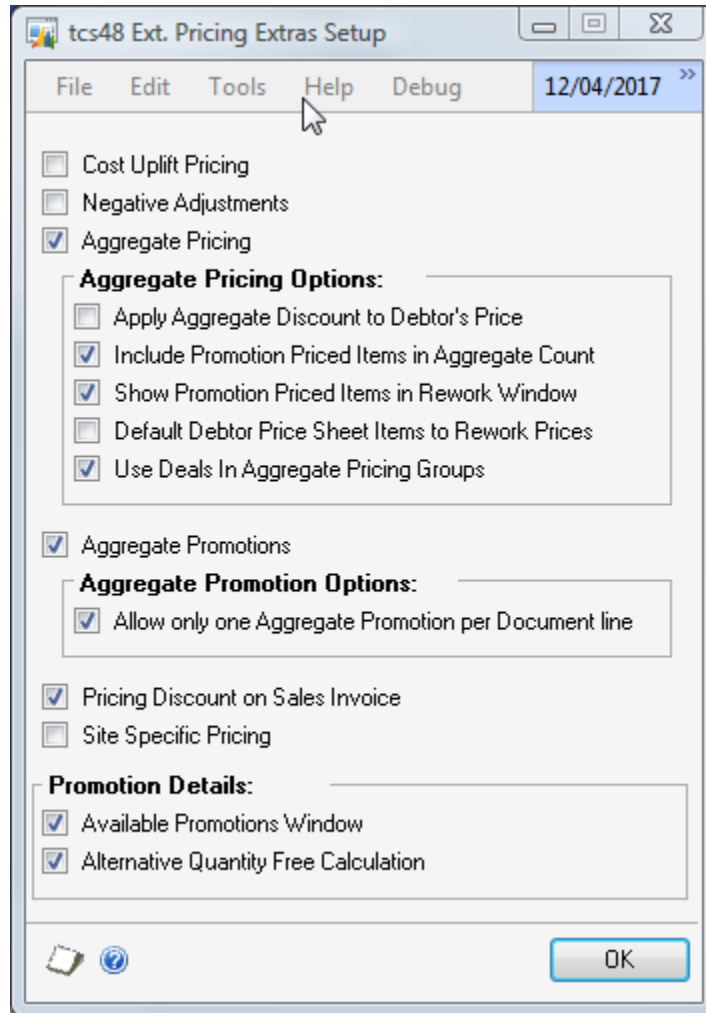

## 1.1 Setting Defaults for Extended Pricing Enhancements

**To set defaults for extended pricing enhancements in the Extended Pricing Extras Setup window:**

1. The following settings are available in the window:

Cost Uplift Pricing	Enables you to calculate a selling price by adding a percentage or value to the cost price. See <a href="#">Cost Uplift Pricing</a> .
Negative Adjustments	Enables you to enter negative values for value adjustments against price sheet items. See <a href="#">Negative</a>

	<a href="#">Adjustments in Price Sheets.</a>
Aggregate Pricing	Enables prices to be determined from the total quantity of a range of items on a sales document. See <a href="#">Aggregate Pricing</a> .
Aggregate Pricing Option: Apply Aggregate Discount to Debtor's Price	If this option is set, any value off or percentage off from the aggregate price book will be applied to the debtor's current price rather than to the base price. See <a href="#">Aggregate Pricing</a> .
Aggregate Pricing Option: Include Promotion Priced Items in Aggregate Count	If this option is set, promotion priced items which are part of an aggregate group will be included in the total quantities for <a href="#">Aggregate Pricing</a> . Turn off this option if you don't want promotion priced items to contribute to aggregate pricing totals.
Aggregate Pricing Option: Show Promotion Priced Items in Rework window	If this option is set, promotion priced items will be displayed in the <a href="#">Aggregate Pricing rework window</a> if an aggregate price is available. Turn off this option if you don't want to see promotion priced items in the <a href="#">Aggregate Pricing rework window</a> .
Aggregate Pricing Option: Default Debtor Price Sheet Items to rework prices	If this option is set, items whose price originated from a debtor price sheet will by default be marked to update in the <a href="#">Aggregate Pricing Rework window</a> .
Aggregate Pricing Option: Use Deals In Aggregate Pricing Groups	If this option is selected, multiple sets of quantity breaks and aggregate price books can be maintained against a single aggregate group in the <a href="#">Aggregate Pricing Group Breaks window</a> . Different customers can then be offered different prices for the same aggregate pricing group.
Aggregate Promotions	Enables free item promotions to be given according to the total quantity of a range of items on a sales document. See <a href="#">Aggregate Promotions</a> .
Allow only one Aggregate Promotion per Document line	If this option is set, a sales document line cannot contribute towards more than one aggregate promotion. When a document line is entered, if the item could contribute to multiple promotions, the user will be prompted to select one. See <a href="#">Aggregate Promotions</a> .
Pricing Discount on Sales Invoices	Enables Visible Discounts functionality. Invoices can be modified to display the discount given on a transaction where the debtor has been set up for visible discounts in the <a href="#">Extended Pricing Enhancements Debtor/Prospect Maintenance window</a> .

	See <a href="#">Visible Discounts</a> .
Site Specific Pricing	Enables Site Specific Pricing functionality with which multiple prices can be set up for items on a site by site basis. See <a href="#">Site Specific Pricing</a> for further details.
Available Promotions Window	If any promotions exist for an item that is selected for a sales transaction then the Available Promotions Info window will be displayed. See <a href="#">Myridas Promotions</a> . Note that this option applies only to single item promotions from promotion price sheets, not to <a href="#">aggregate promotions</a> .
Alternate Quantity Free Calculation	Quantity free calculations will follow the Myridas calculation for working out free quantities rather than the standard calculation. See <a href="#">Myridas Promotions</a> . Note that this option applies only to single item promotions from promotion price sheets, not to <a href="#">aggregate promotions</a> .

Click to select the required options.

2. Click OK to close the window.

Note that if you selected the Cost Uplift Pricing option then the base cost book - called BASECOSTBOOK - will be created automatically.

## 2. Extended Pricing Enhancements Debtor/Prospect Maintenance window



*Cards >> Myridas >> Extended Pricing Enhancements >> Debtor/Prospect Maintenance*

Use the Extended Pricing Enhancements Debtor/Prospect Maintenance window to:

- Set up debtors for Extended Pricing Enhancements functionality

Note that this window is also available as an Additional option from the Debtor Maintenance and Sales Prospect Maintenance windows.

### 2.1 Setting Up Debtors for Extended Pricing Enhancements Functionality

**To set up debtors for aggregate pricing and/or visible discounts in the Extended Pricing Enhancements Debtor/Prospect Maintenance window:**

1. Click to select Customer or Prospect to set up for extended pricing enhancements functionality.
2. Enter a debtor/prospect ID or select one using the lookup.
3. Click the Aggregate Pricing check box to set the selected debtor/prospect for [aggregate pricing](#) functionality.
4. Enter an Aggregate Starting Quantity if required. If you enter an aggregate starting quantity then when sales transactions for this debtor are entered with an aggregate starting quantity greater than the accumulated quantity in the transaction, the aggregate starting quantity will be used to establish the price book that aggregate prices are taken from rather than the actual accumulated transaction quantity.

5. Click the Pricing Discount on Sales Invoice check box to set the selected debtor/prospect for **visible discounts** functionality.
6. Click Save to save your changes and close the window.

Note that you can click Clear at any point to clear entries made in the window.

Click Delete to unassign a debtor/prospect from Extended Pricing Enhancements functionality.

## Cost Uplift Pricing

### 3. Setting Up Cost Uplift Prices

Cost uplift pricing is when a selling price for sales transactions is calculated by adding a value or percentage to the unit cost price. New, mainly underlying, functionality allows you to create cost uplift prices using the Microsoft Dynamics™ GP Extended Pricing windows.

To enable cost uplift pricing functionality you need to select the Cost Uplift Pricing option in the [Extended Pricing Extras Setup window](#). When you select this option for the first time and close the window, a new price book - the BASECOSTBOOK - is created automatically. This price book is used as the basis for cost uplift pricing and follows the same rules as the Microsoft Dynamics™ GP base price book (BASEBOOK).

Prices are not automatically added to the base cost book. To utilise cost uplift pricing you should set up one or more base price sheets and assign them to the base cost book. Add items to price sheets in the Microsoft Dynamics™ GP Price Sheet Maintenance window. You must select the Net Price Only option in this window - only net price sheets can be assigned to the base cost book.

When net prices for the required items have been assigned to the base cost book you should set up one or more cost uplift price sheets for the items. The Microsoft Dynamics™ GP Price Sheet Detail Maintenance window has been amended to include two new price type options, cost uplift value and cost uplift percentage.

*Cost uplift options*



Select one of the cost uplift options when creating a cost uplift price sheet. By default the base cost price book (BASECOSTBOOK) will be selected as the Base Adjusted Price on option. In the Cost Uplift Value field in the scrolling window enter the value or percentage that you want the cost price to be uplifted by in sales transactions. The adjusted price (sheet price + cost uplift value/percentage) will be displayed automatically. All other functionality within the window remains the same as with standard Microsoft Dynamics™ GP.

When a cost uplift sheet has been set up it should be assigned to a suitable debtor or price book. A cost uplift sheet cannot be assigned to the base cost book, as it does not contain net only prices.

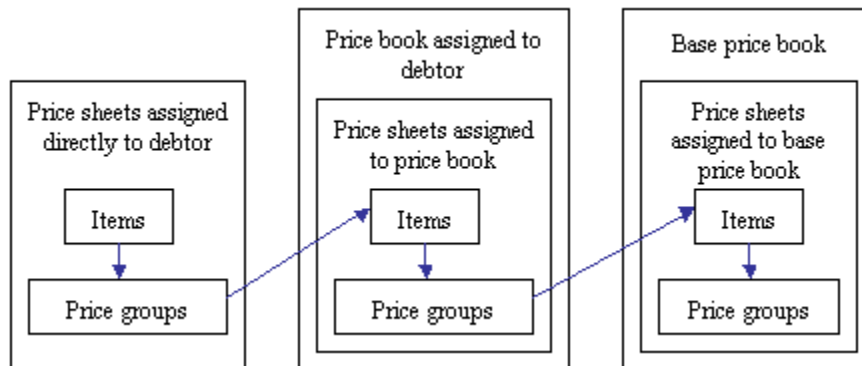
## 4. How Cost Uplift Prices are Calculated

The system searches for cost uplift pricing information in the same way it searches for other price type information but only to book level.

Once a cost uplift price type is found, the cost uplift percentage or value uplift is applied to the base cost book. If the price is found at sheet level it still goes straight to the base cost book to calculate the price and does not apply any other level price calculations. If no price is found on the base cost book then an error is given.

If a cost uplift price is found then the adjusted price will be brought into the sales transaction. The system will be searched for any applicable promotion sheets. If a promotion sheet is found then the cost uplift adjusted price will be amended to take account of any promotional pricing.

Refer to the illustration for more information.



Note that cost uplift prices are calculated and reported on as standard in the Microsoft Dynamics™ GP Extended Pricing and Extended Pricing Error Reports.

## Promotions

### 5. Myridas Promotions

This section described Myridas functionality for single item promotions. See [Aggregate Promotions](#) for details of how to set up promotions based on the total quantity of a range of items.

To enable Myridas promotions functionality you need to select the Promotion Details options in the [Extended Pricing Extras Setup window](#).

#### Available Promotions Window option

Selecting this option will provide additional functionality when entering sales transactions.

With standard Microsoft Dynamics™ GP the Promotion Alert window is displayed only after the quantity of an item required to meet a promotion has been entered into the transaction. If the quantity entered is less than that required to meet the promotion then the user will not know that by increasing the order a promotion would have been available.

With the Available Promotions Window option enabled, when an item on a promotional price sheet is selected in a sales transaction the [Available Promotions Information window](#) will be displayed. This provides the user with full details of promotions that the item is eligible for.

#### Alternative Quantity Free Calculation

Microsoft Dynamics™ GP quantity free promotions allow you to create giveaway promotions. For example, you can create promotions that give away different quantities of free items depending on the quantity of an item purchased by the customer.

Myridas functionality provides an alternate calculation for working out the quantity of free items that should be given. For example, you could set up a promotional price sheet like this:

Purchase Quantity	Quantity of free items
0 to 1	0
2 to 9	1
10 to 99	8
100 to 999999999	100

If a purchase quantity of 50 were entered into a transaction then standard Microsoft Dynamics™ GP would calculate a quantity of 400 free items (purchase quantity (50) x quantity free (8)).

With the Myridas alternate free quantity calculation, if a purchase quantity of 50 were entered into a transaction the free quantity calculated would be 40 (purchase quantity (50) / quantity from (10) x quantity free (8)).

## 6. Available Promotions Information window



*Transactions >> Sales >> Sales Transaction Entry >> Enter an item on a current promotion sheet*

Use the Available Promotions Information window to:

- View promotions for sales items

### 6.1 Viewing Promotions for Sales Items

**To view promotions for sales items in the Available Promotions Information window:**

1. The window will open automatically when you enter an item into a sales transaction that is on a current promotional price sheet.
2. When you have viewed available promotion details click OK to close the window.

## Negative Adjustments in Price Sheets

### 7. Setting Up Negative Adjustments in Price Sheets

With standard Microsoft Dynamics™ GP you cannot enter negative values against price sheet items. With Myridas Extended Pricing Enhancements functionality negative values can be entered against price sheet items for value off adjustments.

To enable this functionality select the Negative Adjustments option in the [Extended Pricing Extras Setup window](#). To enter negative values in price sheets type a - symbol before the quantity to be entered.

Note that negative values are displayed in brackets.

## Visible Discounts

### 8. Setting Up Visible Discounts

With standard Microsoft Dynamics™ GP, printed invoices display the selling price for each line item. Details of any discounts incorporated into the selling price are not explicitly visible.

With Myridas Extended Pricing Enhancements functionality you can use a new report function to display the discount applied to a transaction line on printed sales documents or reports. See [Appendix D Myridas Reports](#) for details on how to implement this functionality in documents and reports.

The actual discount that will be displayed on a modified report is the difference between the price on the BASEBOOK or Price Book/Sheet assigned to a debtor and the actual selling price used in a transaction.

## Aggregate Pricing

Aggregate Pricing functionality enables quantity break pricing to be used in sales transactions to calculate prices for groups of items rather than individual item items. Items are assigned to price books and sheets as with standard Microsoft Dynamics™ GP Extended Pricing, and also assigned to an aggregate price group with each group containing one or more items. Quantity breaks can be set against aggregate pricing groups using the [Aggregate Pricing Group Maintenance window](#), with each quantity break having an aggregate price book assigned to it. If the Use Deals In Aggregate Pricing Groups option is selected in the [Extended Pricing Extras Setup window](#), multiple sets of quantity breaks and price books can be maintained against a single aggregate price group. Different customers can then receive different prices for the same aggregate group.

A setting on the Aggregate Pricing Group determines whether the price break achieved is determined from the total quantity ordered of the items in the group, or from the number of different items ordered.

See [How Aggregate Prices are Calculated](#) for further details.

For total quantity ordered type aggregate groups, aggregate quantities are based on aggregate pricing units and are always accumulated in a single unit i.e. the Aggregate Pricing Unit. These can be set against a unit of measure schedule in the [Aggregate Pricing Unit Of Measure Maintenance window](#) or against individual items in the [Aggregate Pricing Unit Item Maintenance window](#). When aggregate prices are calculated the quantity on a sales transaction will be converted to a quantity in the aggregate pricing unit. Where an item is entered into a transaction in a unit other than the aggregate pricing unit then aggregate pricing functionality will use an equivalence conversion to establish the quantity of the item that is on the transaction in the aggregate pricing unit. This equivalence will be used in establishing an aggregate price.

Debtors and prospects are set up for aggregate pricing functionality using the [Extended Pricing Enhancements Debtor/Prospect Maintenance window](#).

Note that aggregate pricing functionality is not applicable to return transactions or printed invoices.

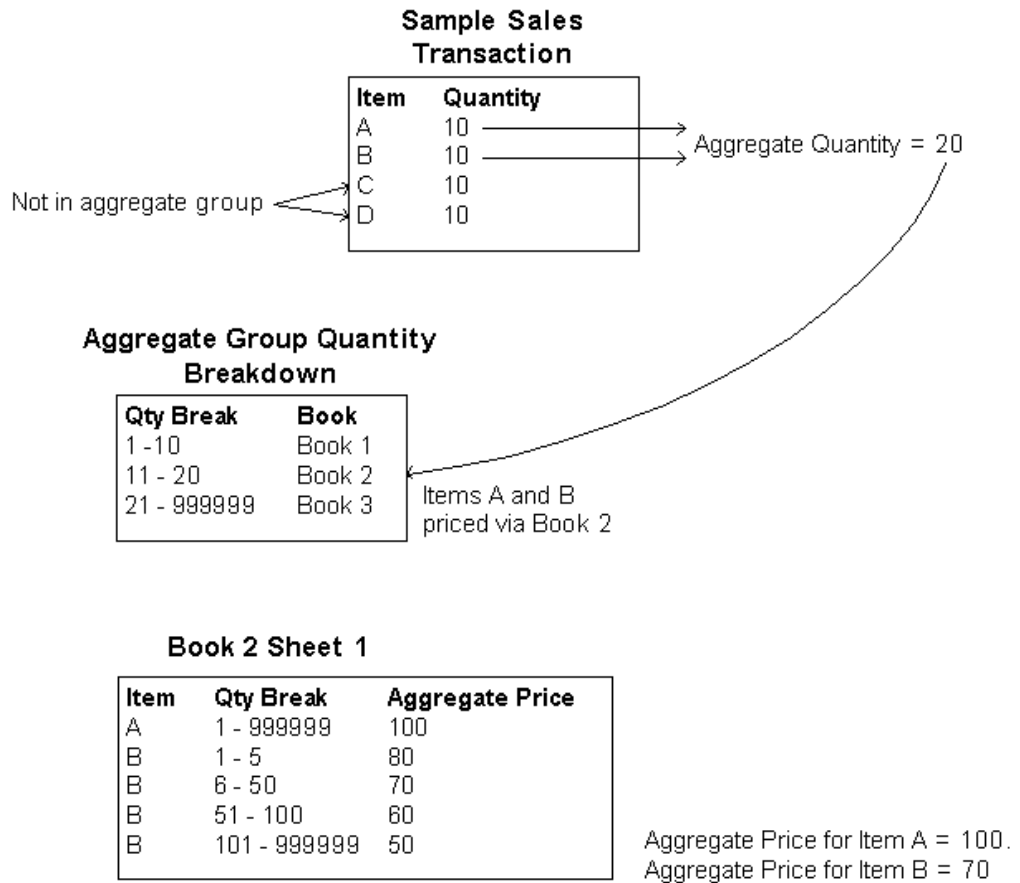
## 9. How Aggregate Prices are Calculated

When a transaction is entered for a debtor set up for aggregate pricing, and you select the rework aggregate prices option during sales transaction entry, aggregate pricing functionality will use the following rules to establish aggregate prices for the items on the transaction.

The following description is for Aggregate Pricing Groups of type Quantity Break Represents Total Quantity. For Quantity Break Represents Item Count type, the calculation is similar, but the total is a count of the items on the transaction, not the total quantity. Aggregate starting quantities do not apply to Quantity Break Represents Item Count type aggregate pricing.

1. If a transaction line is a free quantity promotion line or the item is not in an aggregate group then the line will be excluded from aggregate pricing calculations.
2. Promotion priced items will be excluded from the aggregate pricing quantity unless the option Include Promotion Priced Items in Aggregate Count is set in the [Extended Pricing Extras Setup](#) window.
3. An aggregate pricing unit will be searched for, first against the transaction items, then against the transaction items unit of measure schedules. If no aggregate pricing units are found then the lines will be excluded from aggregate pricing calculations.
4. The aggregate pricing quantity for each qualifying item is calculated by taking the transaction quantity, adjusting the quantity to the base unit of measure equivalence (if it is not already in the base unit of measure), then adjusting the quantity again to the equivalence in the aggregate pricing unit.
5. Item line quantities are now accumulated and cross-referenced to group codes to establish whether aggregate pricing is applicable. If item quantities are eligible for aggregate pricing then each line item will be reassessed.
6. If there is an aggregate starting quantity for the debtor that is greater than the accumulated quantity then this will be used to establish aggregate prices. If the accumulated quantity is greater, the system will use this to establish aggregate prices from the aggregate price books.
7. The system will establish which price book the accumulated quantity achieves in the aggregate price group. It will then look to price sheets assigned to the selected price group and take the appropriate prices, calculating the aggregate price for each item separately. Aggregate prices will then be displayed in the [Aggregate Pricing Rework window](#).

See the following diagram for further explanation of how aggregate prices are calculated.



If the Apply Aggregate Discount to Debtor's Price option is not selected in the [Extended Pricing Extras Setup window](#), the Aggregate book prices will apply as they would if the book were assigned to the debtor. So any values off or percentages are applied to the Base book price.

If the Apply Aggregate Discount to Debtor's Price option is selected in the [Extended Pricing Extras Setup window](#), any values off or percentages are applied to the debtor's current price.

Click the Assign button to display the [Aggregate Pricing Group Allocation window](#) where you can assign items to a group code. Click the Deals/Quantity Breaks button to display the [Aggregate Pricing Group Breaks window](#) where you set up price books against quantity breaks for the group code.

3. Select an Aggregate Price Type from the drop down list:  
Quantity Breaks Represent Total Quantity if the price break achieved is determined from the total quantity ordered of the items in the group,  
or  
Quantity Breaks Represent Item Count if the price break achieved is determined from the number of different items ordered.
4. If you have chosen to Use Deals In Aggregate Pricing Groups in the [Extended Pricing Extras Setup window](#), you have the option to specify a Default Deal. This will be used for any customer not linked to a specific deal. If a default deal is not specified, any customer not assigned to a specific deal will not receive aggregate prices for this group. Note that you cannot specify a default

deal until you have used the [Aggregate Pricing Group Breaks window](#) to set up price books against quantity breaks for the group code.

If you have not chosen to Use Deals In Aggregate Pricing Groups, the Default Deal field will be set automatically to “DEFAULT DEAL” and cannot be changed.

5. Click Save to save changes and close the window.

Standard Microsoft Dynamics™ GP sales transaction entry functionality has been extended to incorporate aggregate pricing functionality. When you enter items set up for aggregate pricing against a debtor set up for aggregate pricing, you can select the Additional Rework Aggregate Prices option to display the [Aggregate Pricing Rework window](#) where aggregated prices will be displayed and available for selection. If this option is selected where ordered items do not qualify for aggregate discounts or the debtor has not been set up for aggregate pricing then the window will not be displayed. See [How Aggregate Prices are Calculated](#) for further details.

If you select to Save, Post, Transfer or Print the document then where aggregate prices are applicable a dialogue box will ask you if you want to rework aggregate prices. Click Yes to display the Aggregate Pricing Rework window.

Note that aggregate prices cannot be calculated against returns transactions, printed invoices or inter-site transfers (see the Myridas Inter-Site Transfers User Guide for further details).

Also note that items given on a free quantity promotion will not be included in aggregate pricing calculations.

In addition, items whose Source of Original Price is set to Sheet will be selected for update if the Default Debtor Price Sheet Items to rework prices option is set in the [Extended Pricing Extras Setup](#) window. All items can be selected or deselected for update by clicking the Update? checkboxes, or by clicking the Mark All/Unmark All buttons.

#### To trace an aggregate price calculation in the Aggregate Pricing Price Trace window:

1. Select Customer or Prospect, and enter a debtor ID or prospect ID, or select one using the lookup.

If an aggregate starting quantity has been set for the selected debtor/prospect then this will be displayed in the Aggregate Starting Quantity field.

2. Enter a currency ID or select one using the lookup.
3. Enter an item number or select one using the lookup.
4. Select a unit of measure from the drop-down menu.
5. Enter a date for the price enquiry.

Note that the current date will be selected by default.

6. Enter a quantity if required. The quantity is used if quantity break pricing is set up for the selected item. The price per item will be calculated.
7. Enter an Accumulated Quantity in Aggregate Unit. This is the aggregate quantity of items in the aggregate group, represented in the aggregate unit. This quantity will be used to find the aggregate quantity break.
8. Click Trace.

The price book that the aggregate price is taken from will be displayed in the Price Book Achieved field.

The Microsoft Dynamics™ GP Price Trace Enquiry window will be displayed showing standard details including the price for the item based on details entered and the price sheet the price is taken from. Click OK to close the Price Trace Enquiry window.

9. Click OK to close the Aggregate Pricing Price Trace window.

Note that you can click Clear at any point to clear any entries made in the window.

## Site Specific Pricing

Site specific pricing functionality enables you to define item prices by their location. You may have items that are sold at different prices dependent upon their site. Site specific pricing is enabled by site price types. Site price types act as a link between sites and price sheets. Both sites and price sheets can be assigned to a site price type. Set up a site price type using the [Site Price Type Maintenance window](#).

When you enter a sales transaction against a site that has been assigned to a site price type, the system will check each item on the transaction to see whether it appears on a price sheet assigned to the site price type. Where items appear on a price sheet assigned to the site price type then that price sheet price will be used in the transaction.

See [Appendix C](#) for details of Myridas windows that incorporate site specific pricing functionality.

Note that if you have site specific pricing switched on then all price sheets in use must be assigned to a site price type.

Also note that site pricing functionality will not be incorporated into Microsoft Dynamics™ GP reporting functions.

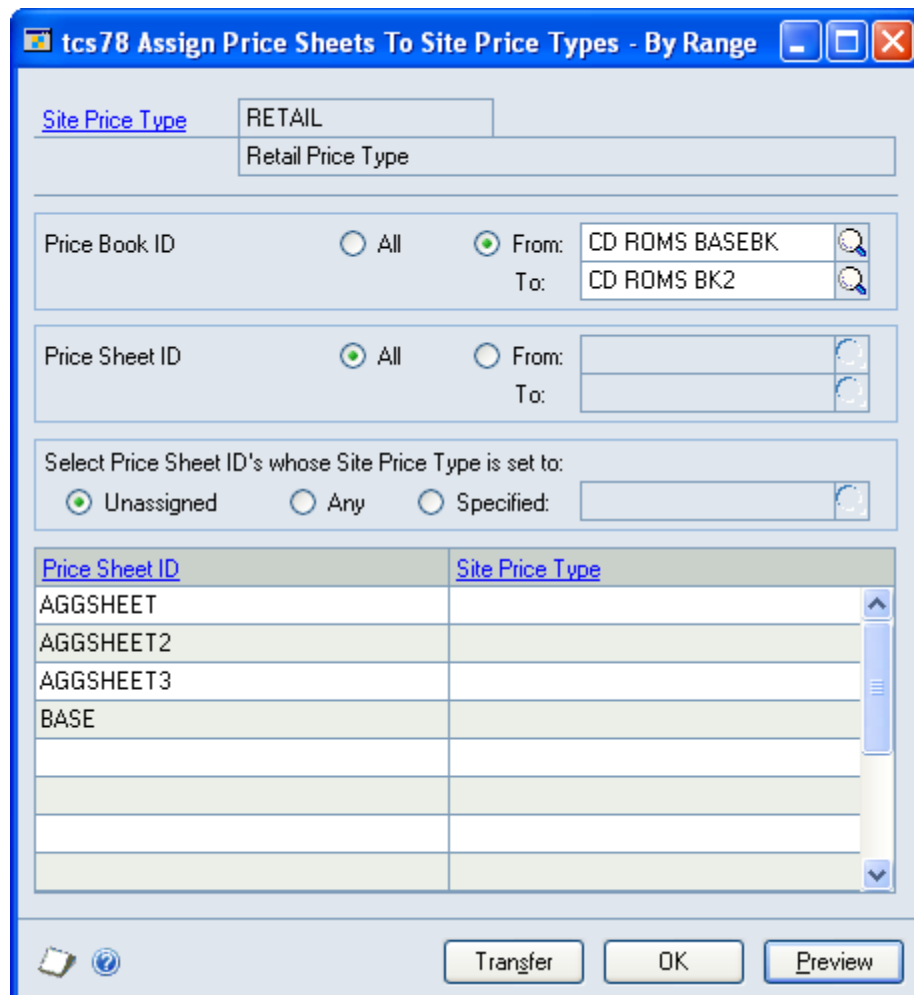

## Order Value Discounts

The Order Value Discount feature allows Trade Discount in Sales Transaction Entry to be automatically calculated as a percentage of the document total.

Customers are assigned to Order Value Discount groups, and each group can have its own set of value bands and discount percentages.

See the [Order Value Discount Group maintenance window](#) for details of how to set up Order Value Discount groups, the [Order Value Discounts – Assign Debtors window](#) for details of how to assign customers to Order Value Discount Groups, and the [Order Value Discount Rates window](#) for details of how to set up order value bands and discount percentages.

Items can be excluded from the Order Value Discount calculation by adding them to a list of excluded items. See [the Order Value Discounts – Excluded Items window](#). The percentage discount will not be applied to items which are excluded from Order Value Discount. A setup option determines whether the value of excluded items is included in the order value total used to set the discount band.

From within Sales Transaction Entry, individual item lines and individual documents can be omitted from Order Value Discount, if the appropriate options are enabled in [the Order Value Discount Setup window](#). A further setup option determines whether the calculated discount percentage can be manually overridden.

### 32. How Order Value Discount is calculated

Order Value Discount is calculated as a percentage of the document subtotal in Sales Transaction Entry. The calculated discount is placed in the Trade Discount field. If Order Value Discount applies to a sales document, the Trade Discount field cannot be edited.

If a Trade Discount percentage is set against the debtor in the Dynamics GP Debtor maintenance window, this takes precedence and Order Value Discount will not be applied to documents for this debtor.

Order Value Discount will be applied when entering a sales document for a debtor who is assigned to an Order Value Discount Group for the originating currency of the document.

As lines are entered, the document subtotal is checked against the break points set up for the Order Value Discount group. If any items on the document are excluded from Order Value Discount, the value used to check against the break points will be reduced by the value of the excluded items, unless the Excluded Items in Total Order Value option is enabled in the [Order Value Discounts Setup window](#). When a break point is achieved, the discount is calculated by applying the percentage to the order value, after the deduction of any items which are excluded from Order Value Discount.

Once the document has been transferred, e.g. an order has been transferred to a fulfilment order or invoice, the percentage achieved is fixed and further changes to the document will not affect the percentage discount achieved.

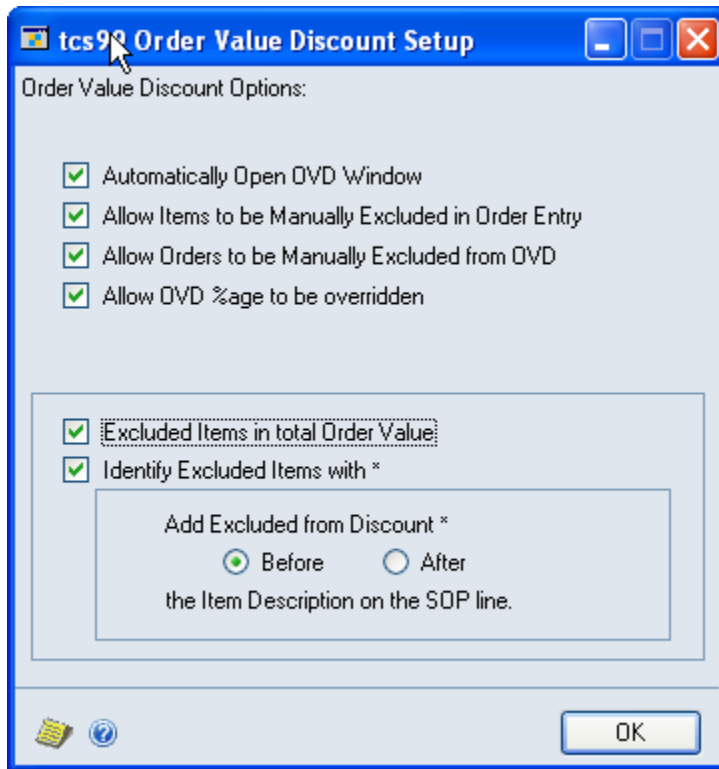

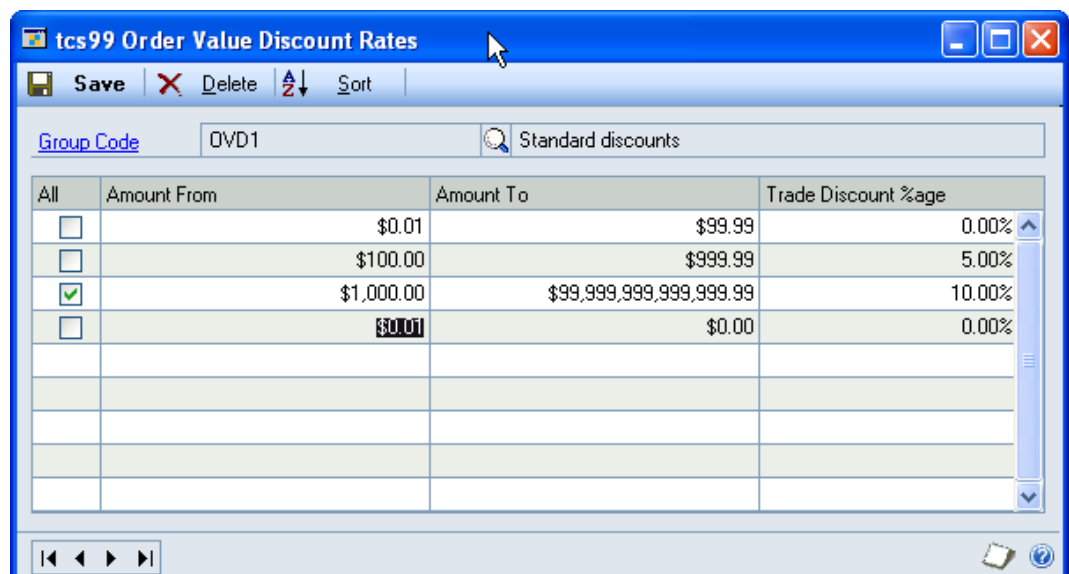

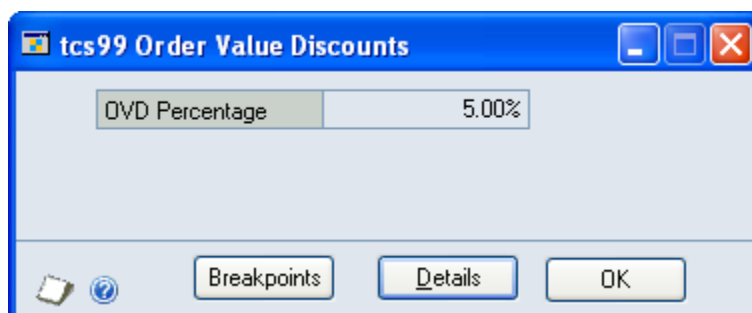

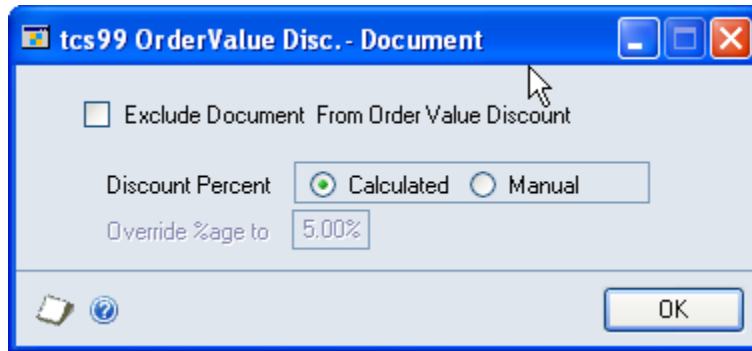

## Aggregate Promotions

An order qualifies for an aggregate promotion if the total quantity of a range of items on the order reaches a specified level, or if the order includes a minimum quantity of every item from a list.

Multiple quantity breaks can be set against a promotion, with different free items offered as the different break points are achieved.

Four types of Aggregate Promotion can be set up:

- Total Quantity promotions – when the total quantity ordered from a list of items reaches a break point, the order qualifies for a free item
- Every item in list – to qualify for the free item, one or more of every item in a list must be ordered
- Variable Quantity list – to qualify for the free item, a specified quantity of every item in a list must be ordered
- Points Allocation – these are similar to Total Quantity promotions, but the total order quantity is used as a number of points. The order qualifies for one or more free items from a list, depending on the number of points achieved.

See the [Aggregate Promotions Maintenance window](#) for details of how to set up an Aggregate Promotion, and see [Aggregate Promotions Maintenance – Free Items window](#), for details of how to set up break points and free items. For details of how to set up the list of items contributing to the promotion, see the [Aggregate Promotions– Assign Items window](#).

An aggregate promotion can be made available to a range of debtors – see [Aggregate Promotions – Assign Debtors window](#).

## 44. How Aggregate Promotions are Calculated

### 44.1 Total Quantity Promotions

To determine whether an order qualifies for a total quantity promotion, the total quantity ordered of the items assigned to the promotion is checked against the promotion break points.

For example:

From Quantity	Free Item Number or List		U of M	Quantity Free	Maximum Quantity Free
10	Item Number	D/12345	Each	1	0

100	List	PRLIST	N/A	2	2
-----	------	--------	-----	---	---

In the above promotion, if the total order quantity is less than 10, the order does not qualify for the promotion.

If the total order quantity is 10 or above, but less than 100, a free item D/12345 is available for every 10 ordered.

If the total order quantity is 100 or above, 2 free items from the item list PRLIST are available. As the Maximum Quantity Free is set to 2, the order does not qualify for more free items at this break point, regardless of increases in the order volume.

An option against each promotion on the [Aggregate Promotions Maintenance window](#) determines whether free items will be offered from multiple quantity breaks. If Allow Free Items from Multiple Quantity Breaks is not enabled, once a higher quantity break is achieved, lower quantity breaks become inactive. So in the example above, an order of 110 would receive only the 2 free items from the higher break point. If Allow Free Items from Multiple Quantity Breaks is enabled, the total quantity will be assessed against both quantity breaks. So in the example above an order of 110 would receive the 2 free items from the higher break point, and 1 free item from the lower break point.

## 44.2 Points Allocation Promotions

As for Total Quantity Promotions, the total order quantity of the items assigned to the promotion is checked against the promotion break points. However, the order total quantity can then be used as a points value to assign to free items from any of the achieved breakpoints.

For example:

From Quantity	Free Item Number or List		U of M	Quantity Free	Maximum Quantity Free

In the above promotion, if the total order quantity is less than 10, the order does not qualify for the promotion.

If the total order quantity is 10 or more, but less than 20, a free item D/12345 is available.

If the total order quantity is, for example, 35, any combination of items from the breakpoints at 10, 20 and 30 can be selected so long as the total “points” used does not exceed 35. The customer could choose to take three of item D/12345; or one of item D/12345 and one item from the list PRLIST; or one of item X12.

If the total order quantity exceeds 50, items from any of the breakpoints can be chosen until all the points have been allocated.

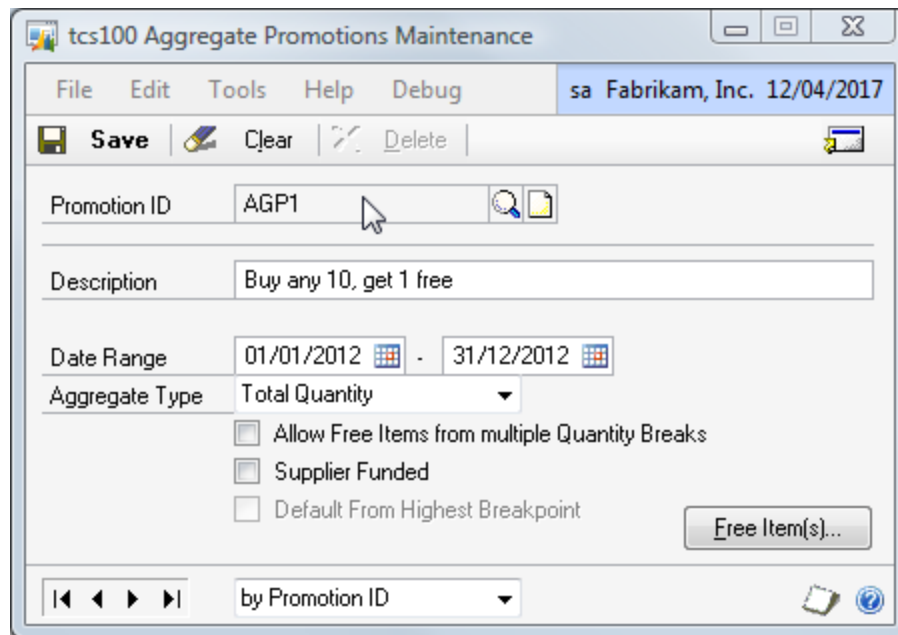

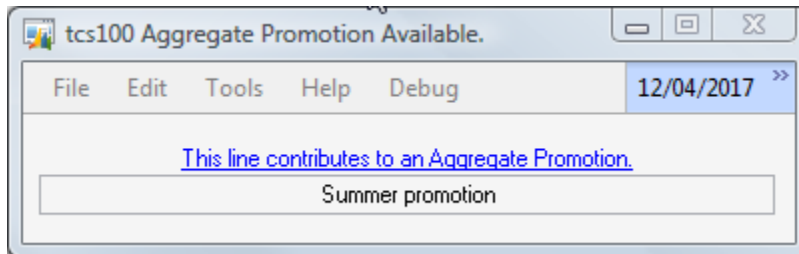

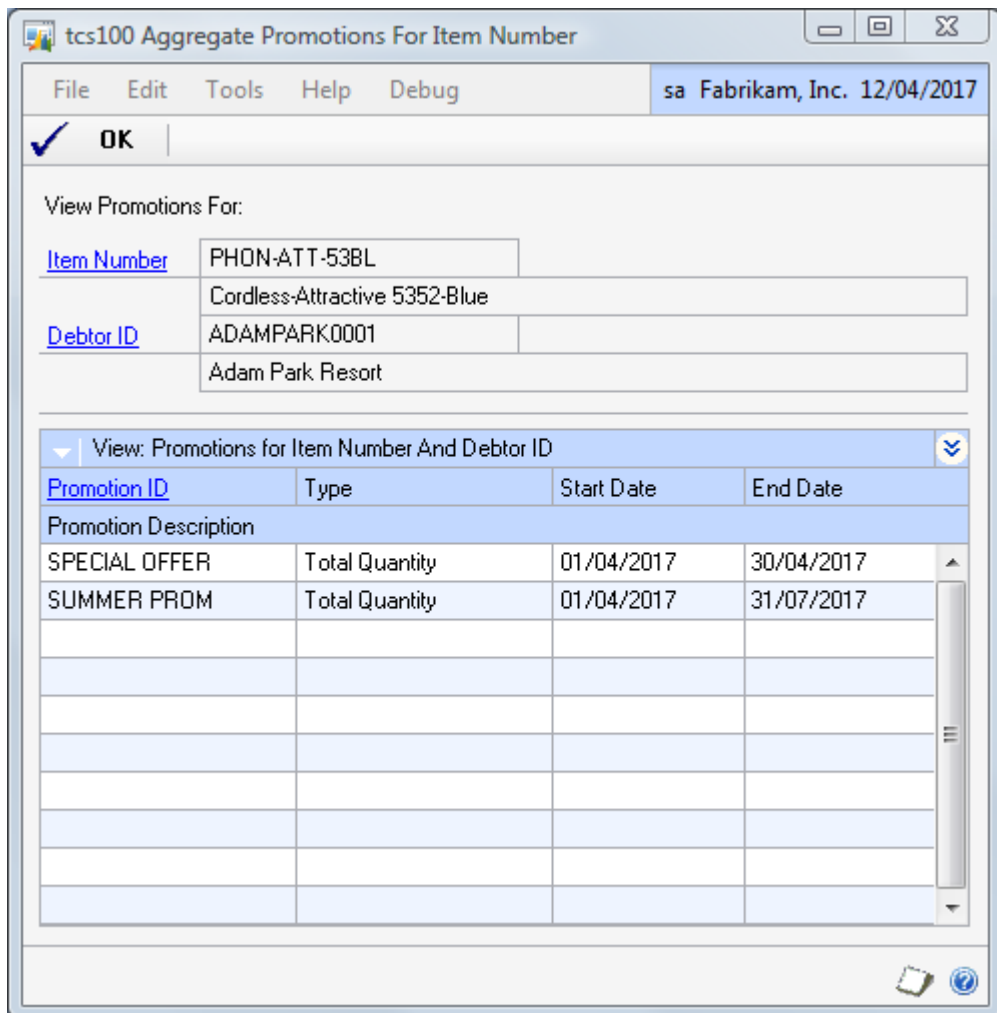

During entry of an order, the progress of aggregate promotion quantities against breakpoints can be viewed in the [Aggregate Promotion Tracker window](#).

When the order is complete, the aggregate promotion free item lines can be reviewed and added using the [Aggregate Promotions – Select Promotions window](#). When the order is saved, the user will be reminded to add the free item lines if they have not already done so. Free item lines can be added only once; further free items cannot be added to an order which already has free promotion lines added.

Aggregate Promotions may be added to quotes and to orders. They can also be added to fulfillment orders and invoices if these are entered directly, i.e. if they have not been created by a transfer from another document.

If an item is part of more than aggregate promotion it will contribute to all of them unless the option to Allow only one Aggregate Promotion per Document line option has been selected in the [Extended Pricing Extras Setup window](#). If this option has been selected, if an item is part of multiple aggregate promotions, the user will be offered a choice of promotions when the item is entered on a document line. Selecting the required Promotion in the Assign Aggregate Promotion to Document Line window, will link the item to one promotion.

## 57.1 Viewing the status of aggregate promotions

### To view the status of aggregate promotions in the Aggregate Promotion Tracker window:

1. The upper scrolling window shows the Aggregate Promotions available to the debtor for whom the current order is being placed.

For total quantity type promotions, the total quantity ordered of the items on the promotion is displayed. If a break point has been reached, the break point quantity and the free quantity achieved are displayed. If applicable, the next break point is also shown. Zoom facilities allow more details of the aggregate promotion to be viewed.

For Every Item in List type promotions, the quantity ordered field shows the lowest quantity ordered of any item in the list. So, for example, if there are six items on the promotion list but only five have been ordered so far, quantity ordered will be displayed as 0. If a quantity of 1 has been ordered of all six items, the quantity ordered will be displayed as 1.

For points allocation promotions, the total quantity ordered and break points are shown as they are for total quantity type promotions. In the Qty Free achieved column, the total points achieved is shown. This is highlighted by a letter P next to the points value.

For Variable Quantity List type promotions, the quantity ordered field is not available in the upper scrolling window.

A letter Q next to the promotion id indicates that this document has qualified for the promotion.

For Every Item in List and Variable Quantity List type promotions, a letter P next to the promotion id indicates that some of the items have been ordered.

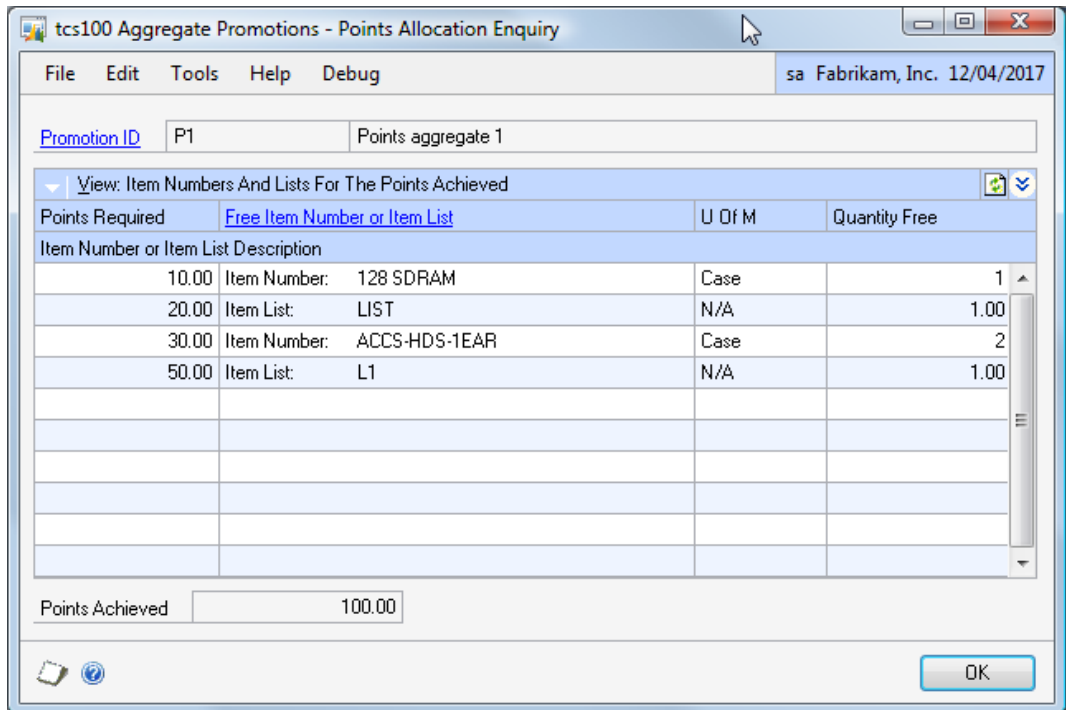
The lower scrolling window shows the items assigned to the promotion and the quantities ordered so far. Items can be added to the order by selecting them from the lower scrolling window.

2. Press OK to close the window.

## 57.2 Viewing the available free items for a Points Allocation Promotion

For a Points Allocation Promotion, when you click on the Free Item Number or List link from the Aggregate Promotion Tracker window, the Aggregate Promotions – Points Allocation Enquiry window will open.

This shows the free items and item lists available for this promotion and the points required for each.

### 58.1 Adding Free Items to an Order

**To add free items to an order in the Aggregate Promotion – Select Promotions window:**

1. The upper scrolling window shows the Aggregate Promotions for which the current order has qualified. For all promotion types except Points Allocation type, the Qty Free Achieved field shows the quantity of the free item that this order has qualified for, and the Qty Taken field shows the quantity of the free item which will be added to the order. For Points Allocation type promotions, the Points Achieved and Points Allocated are shown in these two columns. This is highlighted with a letter P.
2. If the resulting free item is a single item, Qty Taken will have a default value equal to Qty Free Achieved.

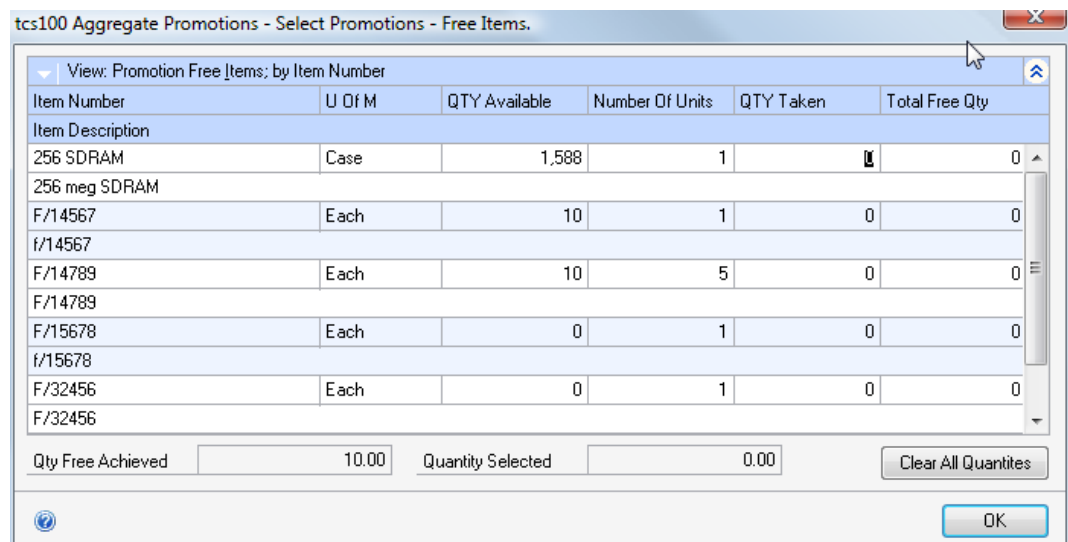
3. If the resulting free item has to be selected from a Free Item List, or if the promotion is a Points Allocation type, the initial value of Qty Taken will depend on whether the system has allocated any default free items. If no defaults have been allocated Qty Taken will be set to 0. If defaults have been used, this will be indicated with a **D**. Use the Qty Taken expansion button to select or edit the items to be added as free items. The expansion button will open the [Aggregate Promotions – Select Promotions – Free Items window](#) or the [Aggregate Promotions – Select Promotions – Points Allocation window](#), depending on the promotion type.
4. Unless an error is detected, the Include check box will be ticked automatically for any line which has a value in Qty Taken. You can omit free lines by removing the tick from the Include checkbox.
5. Click Save to save your free item selections and continue with entry of the sales order., or click Add Free Items to add the lines to the order. The Add Free Items button is only available when the Aggregate Promotions – Select Promotions window is opened on Saving the sales document.
6. As the free items are added, if the system encounters any errors or questions that cannot be answered automatically, the addition of lines will stop and the Sales Item Detail Entry window will open. After replying to the question or dealing with the error you should press save, at which point the addition of any further free lines will continue.

Note that you can click cancel to exit from the Aggregate Promotions – Select Promotions window without adding the free item lines.

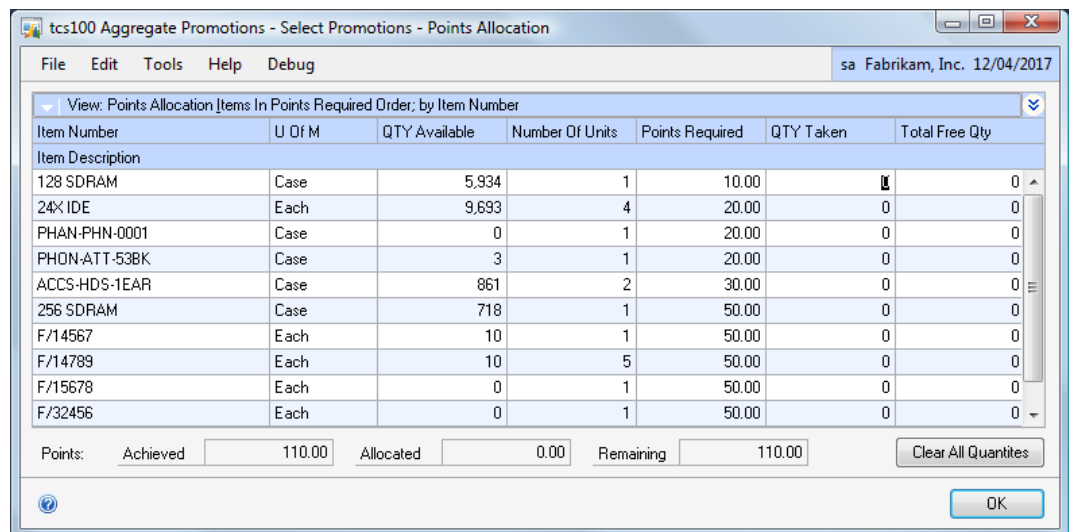

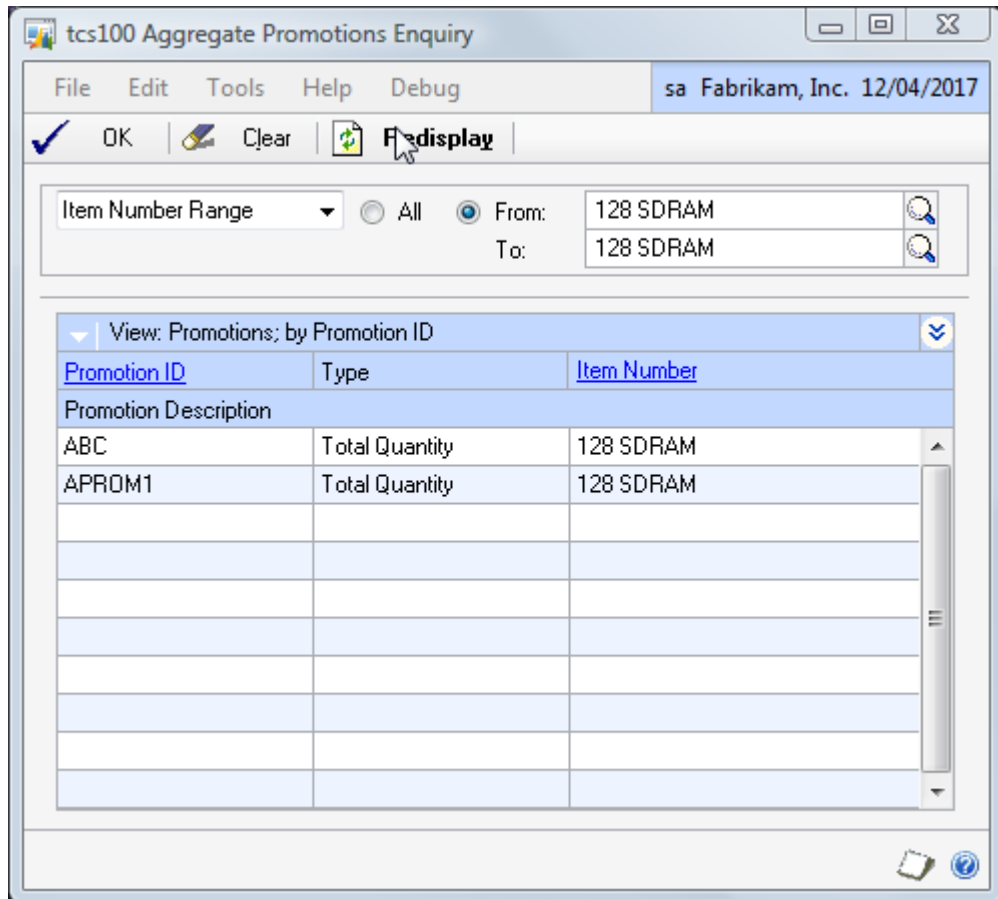

## 60.1 Reporting on Debtor Price Lists

### To report on debtor price lists using the Debtor Price List Production window:

National Account	This option will enable you to print prices for debtors held under a national account. Enter a national account or select one using the lookup. All debtors will be selected by default. Accept this selection or click From and enter from and to range values or select them using the lookups.
Individual Debtor/Prospect	This option will enable you to print prices for a specific debtor or prospect. Enter a debtor or prospect ID or select one using the lookup.  If you select this option then you can also select the Use Template as basis for list option. This will base reported prices on items on a selected template (see Myridas Customer Templates). You should select a ship to address and template ID. Note that the Use Template option is not available if producing price lists for prospects.
Account Range	This option will enable you to print prices for a range of debtors or prospects. All debtors/prospects will be selected by default. Accept this selection or click From and enter from and to range values or select them using the lookups.

3. All Item Class IDs will be selected by default. Accept this selection or click From and enter from and to range values or select them using the lookups.
4. All Item Numbers will be selected by default. Accept this selection or click From and enter from and to range values or select them using the lookups.
5. The current user date will be selected by default as the As at date. Amend this selection as required.

Note that the system will only hold price reports for 3 different dates per debtor or prospect. If you attempt to print a report for a fourth date then the Price List Purge window will be displayed.

Select one or more dates to remove and click Purge or click Cancel to return to the Debtor Price List Production window where you can amend you selection.

6. If you are working in a multi-currency system then the default functional currency will be displayed. Enter a new currency ID or select one using the lookup as required.
7. From the U Of M drop-down menu select to print prices for the Default Selling U Of M only or for All units of measure.
8. From the Get Prices From drop-down menu select to get price from Price Sheets and Books or Price Sheets Only. If you choose Price Sheets and Books, an additional Include Base option is given. Select this to include items where the debtor's price is taken from the Base book.
9. If you are working with [Site Specific Pricing](#) you need to enter a site ID or select one using the lookup.
10. If you want to include [promotional prices](#) in the debtor price report then click the Include Promotions checkbox.
11. By default the price report will be produced in text format. Click the Graphical Cut-down Version checkbox if you want produce the report in graphical format. Note that graphical reports will display only one price for an item.  
  
If you have selected to include promotional prices and are printing a graphical report then by default available promotional prices will be displayed on the report. If you select the Use Best Price only option then the best price will be displayed, even if this is not the promotional price.
12. Click Print then from the Report Destination dialogue box select where the Debtor Prices Report should be printed to.
13. Click OK to close the window.

Note that you can click Clear at any point to clear any entries made in the window.
